

Summary of the:

GQA Level 2 NVQ in Sweeping Servicing and Inspecting Flues and Appliances (Construction) (610/2280/9)

Who is this qualification for?

This qualification is aimed at individuals wishing to prove they have the level and range of knowledge and skills required to sweep, service and inspect flues and appliances . All work must be completed following Industry recognised Safe Working Practices and in accordance with relevant legislations.

This qualification is at Level 2, although some units may be at different levels and should be taken by those who are fully trained to deal with a range of tasks and situations and carry out the installation work in situations that have complex requirements.

Entry requirements

There are no formal entry requirements for learners undertaking this qualification. However, centres must ensure that learners have the potential and opportunity to gain the qualification successfully.

This qualification has been designed and developed by CITB as the Standards Setting Body for the Construction industry.

Qualification achievement

Although It is not expected that all workers will complete exactly the same tasks, the qualification is made up of 4 mandatory units, with a total credit value of 31 credits.

GQA are made up of units that have a credit value or credits. These credits must be achieved in the correct combination of mandatory and optional units. Qualifications are now required to indicate the total qualification time (TQT), this is to show the typical time it will take someone to attain the required skills and knowledge to meet the qualification criteria. The TQT for this qualification is 310 hours.

Qualifications are also required to indicate the number of hours of teaching someone would normally need to receive in order to achieve the qualification. These are referred to as Guided Learning Hours (GLH). The GLH for this qualification is 144.

The units of assessment set out learning outcomes which describe what learners need to be able to do and understand. The learning outcomes are defined by assessment criteria which are used to assess competence, expressed as skills achieved and learned knowledge and understanding, to achieve the units. Achievement of the mandatory unit and optional units will mean the qualification has been completed and will be subject to approval of a claim for certification. GQA will issue a certificate complete with the learner's name, the qualification and unit titles and the credits achieved.
